1 Executive Summary / Introduction

NuCoal Resources Ltd (**NuCoal**) is an Australian-listed coal mining company based in Toronto, NSW. In September 2011, NuCoal acquired Dellworth Pty Ltd (**Dellworth**) which holds the Savoy Hill Exploration Licence (**EL 6812**) located within the Bayswater Power Station Complex in the Upper Hunter Valley, NSW.

EL 6812 currently applies to an area of approximately 2,024 hectares containing mainly grazing and unimproved pastures. The tenement is located near the AGL Macquarie power station on the New England Highway between Singleton and Muswellbrook. The freehold land within the tenement area is predominantly owned by AGL Macquarie, with the remainder owned by Malabar Coal and Hunter Valley Energy Coal respectively.

Dellworth has received renewal of EL 6812 for a six year period over only 1,613 hectares of the current tenement area. The remainder area is to be relinquished as exploration has established that it is not economically viable.

This document is the Annual Community Consultation Report (**Annual CCR**) which is supported by the Environmental Management Plan (**EMP**) for exploration studies within EL 6812 and the Community Consultation Plan (**CCP**) for exploration.

Extensive drilling has been completed within EL 6812 in the past, however, during this reporting period, there have been no on-ground exploration activities. In addition, the Company has received no complaints or enquiries during the period.

1.1 Location

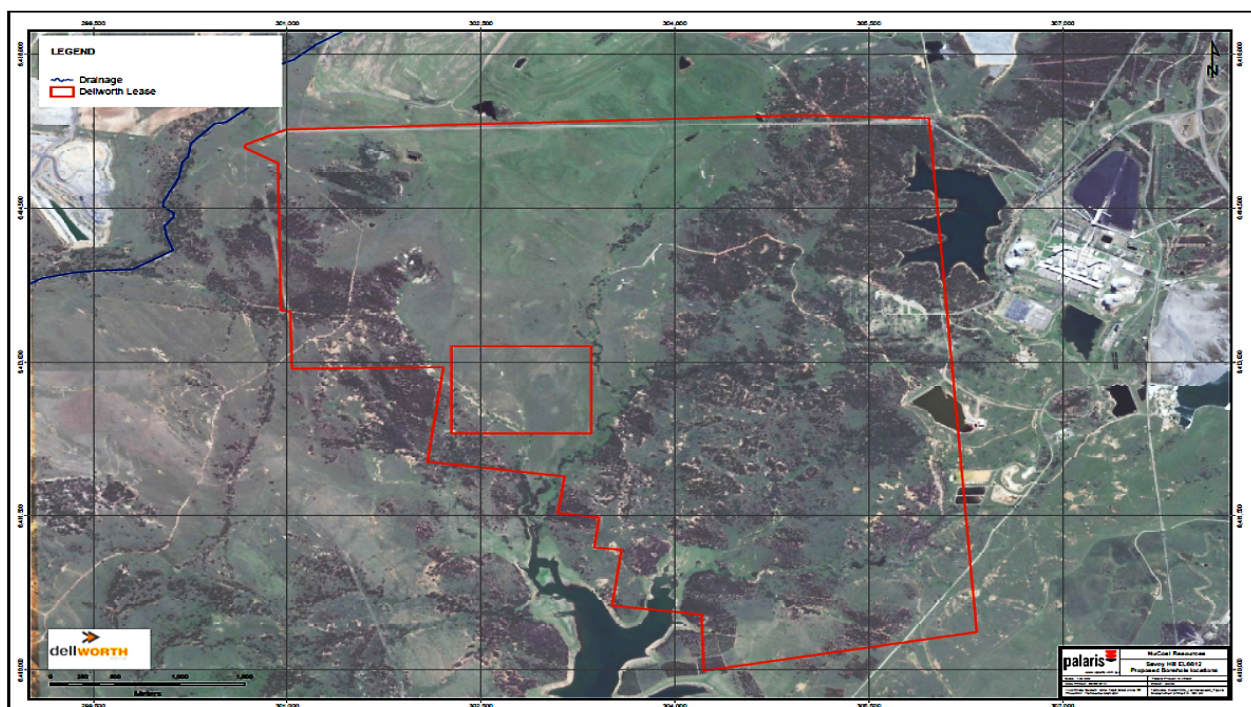


Figure 1 – EL 6812

EL 6812, as shown on **Figure 1**, is located approximately 20 km south of Muswellbrook in the Upper Hunter Valley of New South Wales. EL 6812 is located in both the Muswellbrook and Singleton Local Government Areas, immediately north of the Plashett Reservoir and to the west of the Bayswater Power Station.

1.2 Activities

No recent drilling or other exploration activities have been completed by NuCoal since the initial drilling program was undertaken during October 2011 to February 2013. The Phase 1 and 2 drilling program completed during the previous term of the licence comprised 35 boreholes distributed across the full area of the licence.

As the renewal application was under assessment from June 2018 to October 2022, the Company did not progress the Phase 3 drilling program beyond the updating of landholder access agreements.

However, now that renewal has been sought, the Company is proceeding to undertake the work schedule specified in the renewal. The program includes a phase 3 drilling program of seven cored holes to provide data on resource quantum and quality for the 6 coal seams known to occur on EL 6812.

Planned Exploration Program

The planned exploration program is being undertaken without delay, and allows for obtaining the required approvals with relevant stakeholders before on the ground drilling is possible, which in our case comprises AGL and the NSW Government. In AGL's case, site access requires completion of an access and compensation agreement.

Works Schedule

Year	Work Scheduled
Year 1 (2023)	Apply for all required approvals for phase 3 drilling and conduct a complete third party review of all previous exploration activities and studies.
Year 2 (2024)	Drilling of 3 holes including coal quality testing.
Year 3 (2025)	Complete drilling of another 4 holes (7 in total) including 4 groundwater monitoring holes.
Year 4 (2026)	Complete remaining 4 groundwater monitoring holes (8 in total).
Year 5 (2027)	Commence Environmental Impact Statement (EIS) and Pre-Feasibility Studies.
Year 6 (2028)	Continue EIS and prepare Feasibility documentation including Renewal.

1.3 Community Consultation Plan Summary

The Savoy Hill CCP has been developed to comply with Licence conditions 5-7 - Community Consultation, whereby NuCoal:

- Must engage with the community in relation to the planning for and conduct of prospecting activities in accordance with the Guidelines for community consultation requirements for exploration of coal and petroleum, including coal seam gas (NSW Trade and Investment 2012); and
- Submit an annual report on community consultation within 28 days of the anniversary of the licence being granted.

1.4 Annual Community Consultation Report Purpose and Objectives

The purpose of this Annual CCR is to document stakeholder engagement for the purpose of addressing licence conditions 5-7. Refer Summary of Stakeholder Engagement per **Table 1** below, which details

activities undertaken, as identified in the Communications Strategy: Methods of Communications with Stakeholders.
